**STIPULATION TO EXTEND DEADLINE FOR MOVING TO AMEND PLEADINGS
OR ADD PARTIES UNTIL DECEMBER 1, 2009**

The Court's current schedule for these cases requires plaintiffs to amend the pleadings or add new parties by October 2, 2009. The parties have agreed, subject to the Court's approval, to an extension of that deadline for sixty days, or until December 1, 2009.

In support of that stipulation, the parties state:

WHEREAS, discovery has commenced in these cases, but is not yet complete;

WHEREAS, plaintiffs believe that additional time is needed to further inform their determination of the necessity of amending the Consolidated Amended Class Action Complaint;

WHEREAS, defendants agree to an extension of sixty (60) days for plaintiffs to amend the pleadings and/or add new parties; and

WHEREAS, such an extension will not have any effect on other dates currently on the Court's schedule for the progression of these cases.

NOW THEREFORE, the parties, by and through their respective counsel, and subject to the approval of the Court, hereby stipulate that the deadline to amend the pleadings or add parties may be extended until December 1, 2009.
