JOINT MOTION OF THE DEBTORS, THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS, CERTAIN ADMINISTRATIVE CLAIMANTS, AND PNC BANK N.A., FOR AN ORDER PURSUANT TO RULE 9019 OF THE FEDERAL RULES OF BANKRUPTCY PROCEDURE (I) RESOLVING PNC'S MOTION TO ESTABLISH THE AMOUNT OF PREPETITION AGENT'S AND PREPETITION LENDERS' ALLOWED ADMINISTRATIVE EXPENSE CLAIM AND (II) APPROVING SETTLEMENT AND COMPROMISE BETWEEN THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS AND CERTAIN ADMINISTRATIVE CLAIMANTS WITH RESPECT TO A SHARING ARRANGEMENT OF AVOIDANCE ACTION RECOVERIES

The Official Committee of Unsecured Creditors (the "Committee"), on behalf of all general unsecured creditors, Arch Aluminum & Glass Co., Inc. ("Arch Aluminum") and four (4) of its subsidiaries and affiliates, as jointly administered debtors and debtors-in-possession in the above-captioned cases (collectively, the "Debtors"), the William L. Bonnell Company, Inc., Zeledyne, LLC, Guardian Industries, Corp. and Pilkington North America, Inc. (collectively the "Administrative Claimants"), on behalf of all holders of allowed administrative expense claims under 11 U.S.C. § 503(b)(9) exclusively, and PNC Bank N.A. ("PNC")² file this Joint Motion of

the Debtors, the Official Committee of Unsecured Creditors, Certain Administrative Claimants, and PNC Bank, N.A. for an Order Pursuant to Rule 9019 of the Federal Rules of Bankruptcy Procedure (I) Resolving PNC's Motion to Establish the Amount of Prepetition Lenders' Allowed Administrative Expense Claim and (II) Approving Settlement and Compromise Between the Official Committee of Unsecured Creditors and the Administrative Claimants with Respect to a Sharing Arrangement of Avoidance Action Recoveries (the "Settlement Motion"). In support of the Settlement Motion, the Parties respectfully state the following:

JURISDICTION AND VENUE

1. This Court has jurisdiction to consider this Settlement Motion pursuant to 28 U.S.C. §§ 157 and 1334. Venue is proper in this District pursuant to 28 U.S.C. §§ 1408 and 1409. This matter is a core proceeding pursuant to 28 U.S.C. § 157(b).

2. The statutory predicates for the relief requested herein are 11 U.S.C. §§ 364(c)(1), 503(b), 507(b) and Rule 9019 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules").

GENERAL BACKGROUND

3. On November 25, 2009 (the "Petition Date"), the Debtors filed voluntary petitions seeking relief under Chapter 11 of Title 11 of the United States Code, 11 U.S.C. § 101, *et seq.* (the "Bankruptcy Code").

4. On December 2, 2009, the Debtors filed the Debtors' Motion for Entry of Orders Pursuant to Sections 105, 363, and 365 of the Bankruptcy Code and Federal Rules of Bankruptcy Procedure 2002, 6004, 6006 (A) Approving Asset Purchase Agreement with Arch Glass Acquisition Corporation, an Affiliate of Grey Mountain Partners, (B) Authorizing the Debtors to Enter into Asset Purchase Agreement with Arch Glass Acquisition Corporation, (C) Establishing Bidding Procedures for the Sale of All or Substantially All of the Debtors' Assets Free and Clear

of All Liens, Claims, Encumbrances and Interests; (D) Authorizing the Debtors to Provide Certain Stalking Horse Bid Protections; (E) Scheduling a Hearing to Consider the Approval of and Approving the Form and Manner of Notice in Connection therewith and (H) Granting Related Relief (the “Sale Motion”) [DE 29].

5. On December 22, 2009, the Court entered the Order Granting Certain Relief Requested in Debtors’ Motion for Entry of Orders Pursuant to Sections 105, 363, and 365 of the Bankruptcy Code and Federal Rules of Bankruptcy Procedure 2002, 6004, 6006 (A) Approving Asset Purchase Agreement with Arch Glass Acquisition Corporation, an Affiliate of Grey Mountain Partners, (B) Authorizing the Debtors to Enter into Asset Purchase Agreement with Arch Glass Acquisition Corporation, (C) Establishing Bidding Procedures for the Sale of All or Substantially All of the Debtors’ Assets Free and Clear of All Liens, Claims, Encumbrances and Interests; (D) Authorizing the Debtors to Provide Certain Stalking Horse Bid Protections; (E) Scheduling a Hearing to Consider the Approval of and Approving the Form and Manner of Notice in Connection therewith and (H) Granting Related Relief (the “Sale and Bid Procedures Order”) [DE 144].

6. On December 11, 2009, the Office of the United States Trustee (the “U.S. Trustee”) appointed the Committee [DE 95].

7. On January 12, 2010, the Debtors conducted an Auction in accordance with the Sale and Bid Procedures Order. Arch Glass Acquisitions Corporation³ (“Acquisitions”) and Arch Aluminum & Glass Enterprises, Inc.⁴ (“Enterprises”) participated in the Auction. At the

conclusion of the Auction, the Debtors, in consultation with the Committee and the Pre-Petition Lenders, determined that the bid submitted by Enterprises was the highest and best bid for substantially all of the Debtors' assets, and this Court found that such determination was reasonable.

8. On January 12, 2010, the Committee filed an objection (the "Committee Sale Objection") to the Sale Motion opposing the Debtors' proposed sale of certain unencumbered assets, including certain avoidance actions, in the absence of any valuation evidence concerning the unencumbered assets to be sold and in the absence of any testimony concerning the proposed allocation of the purchase price for these particular unencumbered assets.

9. On January 13, 2010, PNC also filed an objection (the "PNC Sale Objection") to the Sale Motion whereby PNC opposed approval of the sale on the grounds that: (a) absent consent, the Debtors could not sell their assets free and clear of PNC's liens under section 363(f) of the Bankruptcy Code; (b) the asset purchase agreement executed by the Stalking Horse was subject to numerous adjustments which make it impossible to determine the true purchase price of the assets and whether they were being sold for fair values; (c) the proposed sale values were insufficient to fully extinguish the existing indebtedness; and (d) the two proposed asset purchase agreements attempted to improperly compromise the intercompany promissory notes between Arch Canada, ULC and Arch Aluminum and Glass International, Inc.

10. On January 20, 2010, the Debtors filed the Expedited Motion to Establish a Bar Date for the Filing of Motions Seeking the Allowance and/or Payment of Administrative Expense Claims and to Designate the Form and Manner of Notice of Administrative Claims Bar Date (the "Administrative Claim Bar Date Motion") [DE 247].

11. Shortly thereafter, on January 27, 2010, the Court entered an Order Pursuant to Sections 105, 363, and 365 of the Bankruptcy Code and Federal Rules of Bankruptcy Procedure 2002, 6004, and 6006: (A) Approving Asset Purchase Agreement; (B) Authorizing Sale of Substantially All of the Debtors' Assets Free and Clear of All Liens, Claims, Encumbrances; and (C) Authorizing Assumptions and Assignment of Certain Lease and Executory Contracts [DE 294] (the "Sale Order") approving the sale of substantially all of the Debtors' assets to Enterprises and resolving all objections, responses, and requests for continuance concerning the Sale Motion. Additionally, the Court entered a Final Order (1) Authorizing Debtors in Possession to Obtain Secured Postpetition Financing with Priority Set Forth Herein, (B) Approving Agreements Relating to the Foregoing; (C) Authorizing Use of Cash Collateral; and (D) Granting Related Relief and (2) Approving Settlement and Compromise Between the Debtors and the Official Committee of Unsecured Creditors and the Prepetition Lenders [DE 294] (the "Settlement Order").

12. Pursuant to the Settlement Order, PNC consented to a carve out of its cash collateral derived from the sale for the benefit of the general unsecured creditors in the amount of \$1,250,000 plus an assignment of one hundred percent (100%) of any recoveries PNC may receive in partial satisfaction of its allowed super-priority administrative expense claim, pursuant to 11 U.S.C. § 507(b), from recoveries by the Debtors or their estates in respect of the Avoidance Action Payments.⁵ The amounts to be paid to the general unsecured creditors by PNC, from recoveries of the Avoidance Action Payments, comprise a carve out of PNC's court-approved, super-priority administrative expense claim recoveries. *See* Settlement Order, ¶¶ 35-37.

13. On January 27, 2010, the Court also entered the Order granting the Administrative Claim Bar Date Motion (the “Administrative Claim Bar Order”) [DE 297]. The Administrative Claim Bar Order establishes February 19, 2010 as the deadline for all creditors or parties-in-interest to file a motion with the Court to seek allowance and/or payment of administrative claims under Section 503(b).

14. In accordance with the Administrative Claims Bar Order, on February 18, 2010, PNC timely filed its Motion to Establish the Amount of Prepetition Agent’s and Prepetition Lenders’ Allowed Administrative Expense Claim (the “PNC Motion”) [DE 364].

15. On February 23, 2010, the Administrative Claimants filed a preliminary objection to PNC’s Motion to Establish the Amount of Prepetition Agent’s and Prepetition Lenders’ Allowed Administrative Expense Claim (the “Administrative Claimants’ Objection”) [DE 391].⁶

16. Also on February 23, 2010, the Committee filed its limited objection to PNC’s Motion to Establish the Amount of Prepetition Lenders’ Allowed Administrative Expense Claim (the “Committee Objection”) [DE 394].

17. Additionally, on February 23, 2010, the Debtors’ filed their Omnibus Response to Various Requests for Administrative Claims (the “Response”) [DE 393].

18. On June 29, 2010, the Court held a hearing on the PNC Motion, the Administrative Claimants’ Objection, the Committee Objection, and the Response (the “Hearing”). At the Hearing, the Committee announced that it, on behalf of all general unsecured creditors, the Administrative Claimants, PNC, and the Debtors had reached a settlement to

resolve the PNC Motion, the Administrative Claimants' Objection, the Committee Objection, and the Response (the "Settlement").

THE PROPOSED SETTLEMENT AND COMPROMISE

19. As more fully described herein the terms of the Settlement are as follows:

A. Pursuant to sections 503(b), 507(b), and 364(c)(1), PNC shall have an allowed super-priority administrative expense claim in the amount of \$8,000,000⁷;

B. Pursuant to the Settlement Order, PNC has assigned to the general unsecured creditors any and all cash proceeds it receives on its allowed super-priority claim exclusively from the Avoidance Action Payments;

C. The Committee, on behalf of the general unsecured creditors, has agreed to remit thirty percent (30%) of the funds received from PNC on the Avoidance Action Payments through the partial assignment to all creditors holding allowed administrative expense claims pursuant to 11 U.S.C. § 503(b)(9) (the "503(b)(9) Creditors") with the general unsecured creditors retaining the remaining seventy percent (70%) of the Avoidance Action Payments; and

D. The Avoidance Action Payments shall be credited against PNC's allowed \$8,000,000 super-priority administrative expense claim, as they are received, and PNC's super-priority administrative expense claim shall be reduced dollar for dollar on account of any and all Avoidance Action Payments. For the avoidance of doubt, PNC shall not receive any distributions on its allowed super-priority expense claim from that portion of the Avoidance Action Payment shared by the general unsecured creditors with the 503(b)(9) Creditors.

RELIEF REQUESTED

20. Bankruptcy Rule 9019 provides, in relevant part, that on proper notice and a hearing, the Court may approve a compromise and settlement. The Settlement Motion has been properly noticed to, among other parties, all general unsecured creditors and all 503(b)(9) Creditors pursuant to Rule 2002 of the Federal Bankruptcy Rules of Procedure.⁸

21. The standards for approving a settlement are well settled. The Court is required to exercise its sound discretion in assessing the reasonableness of a proposed settlement. *See In re Honeywell*, 93 B.R. 291, 294 (Bankr. S.D. Fla. 1988); *In re Jackson Brewing, Co.*, 624 F.2d 599 (5th Cir. 1980); *In re Teltronics Services, Inc.*, 762 F.2d 185 (2d Cir. 1985).

22. The proposed Settlement resolves litigation as to both the amount of PNC's allowed super-priority administrative expense claim and the priority of distributions of the Avoidance Action Recoveries as between the Committee and the 503(b)(9) Creditors in accordance with the Settlement Order. In considering whether to approve a settlement that resolves possible litigation, the bankruptcy court's central inquiry is whether the proposed settlement is "fair and equitable" and in the best interests of the estate. *See, e.g. Protective Comm. for Indep. Stockholders of TMT Trailer Ferry, Inc. v. Anderson*, 390 U.S. 414, 424, (1968) (noting that "[c]ompromises are a 'normal part of the process of reorganization,'" and further holding that, in determining whether a settlement is in the best interests of the estate, the court must consider whether the settlement is "fair and equitable") (citation omitted); *In re*

⁸ Pursuant to the Administrative Claim Bar Order, all parties-in-interest holding an administrative expense claim pursuant to 11 U.S.C. § 503(b) were required to file a motion for allowance of their respective administrative expense claims on or before February 19, 2010. Insofar as the Debtors objected to all, or most, of the timely filed administrative expense claims, and the Court has adjudicated all of the Debtors' objections thereto, with the sole exception of PNC's claim; all allowed 503(b)(9) claims have been liquidated. Hence the 503(b)(9) Creditors that will necessarily have their rights impacted by this Settlement and have been served with the Settlement Motion.

Southeast Banking Corp., 314 B.R. 250, 272-73 (Bankr. S.D. Fla. 2004) (holding that a bankruptcy court considers whether a settlement is “fair and equitable”).

23. Moreover, the Eleventh Circuit in *In re Justice Oaks II, Ltd.*, 898 F.2d 1544, 1549 (11th Cir. 1990) established four factors for the court to consider in determining whether to approve a settlement. Specifically, the *Justice Oaks II* test requires the court to consider:

- a. The probability of success in the litigation;
- b. The difficulties, if any, to be encountered in the matter of collection;
- c. The complexity of the litigation involved and the expense, inconvenience, and delay necessarily attendant to it, and;
- d. The paramount interest of creditors and a proper deference to their reasonable views.

24. The Parties believe, in their sound business judgment, that executing and performing under the Settlement is fair and equitable and is in the best interests of the estates and the creditors. Moreover, the Settlement resulted from arms’ length, good faith negotiations among the Parties over a significant period of time.

25. The proposed Settlement results in PNC being allowed a super-priority administrative expense claim in the amount of \$8,000,000, which is less than half of the \$17,200,000 the lenders requested in the PNC Motion. The reduction of PNC’s super-priority claim substantially reduces the potential claim pool in these cases, thereby benefiting all creditors with junior claims.

26. Furthermore, under the terms of the proposed Settlement, the 503(b)(9) Creditors will receive thirty percent (30%) of the Avoidance Action Payments and all general unsecured creditors will receive seventy percent (70%) of the Avoidance Action Payments. This Settlement is fair and equitable to the general unsecured creditors and the 503(b)(9) Creditors based upon

the likelihood of success in litigating the amount of PNC's allowed super-priority administrative expense claim and the complexity and expense of the potential litigation.

27. If the proposed Settlement is not approved, litigation as to the amount of PNC's allowed super-priority administrative claim could lead to a wide range of recoveries for the general unsecured creditors and the 503(b)(9) Creditors. Pursuant to the Settlement Order, the general unsecured creditors have the right to receive one hundred percent (100%) of all recoveries received from the Avoidance Action Payments; however, because these recoveries flow through PNC's allowed super-priority administrative expense claim as a carve out, if the amount of PNC's allowed super-priority administrative expense claim is less than the recoveries realized from the Avoidance Action Payments, the general unsecured creditors will lose their recovery as to the extent the Avoidance Action Payments exceed PNC's allowed super-priority administrative expense claim. Consequently, if the Administrative Claimants are successful in reducing PNC's super-priority administrative claim below the total amount of the recoveries from the Avoidance Action Payments, or having said claims disallowed in its entirety through litigation, the general unsecured creditors will receive either substantially less than 100% of the recoveries from the Avoidance Action Payments or nothing, as the monies will be used to satisfy the claims of creditors with higher priority than the general unsecured creditors. The Administrative Claimants also face risks in litigating the amount of PNC's allowed administrative expense claim. If the court concludes that PNC's super-priority administrative claim should be allowed in an amount that exceeds the recoveries from the Avoidance Action Payments, the 503(b)(9) Creditors will receive no portion of this recovery based upon the terms and provisions of the Settlement Order.

28. The likelihood of either the Committee or the Administrative Claimants succeeding in the litigation as to the amount of PNC's super-priority administrative expense claim is at best uncertain. The Committee and the Administrative Claimants have each advanced compelling positions in the course of settlement negotiations that a court could find convincing in determining the amount of PNC's allowed super-priority administrative expense claim to the benefit of one side and the detriment of the other.

29. Litigating the amount of PNC's allowed diminution claim under 11 U.S.C. § 507(b) has the very real potential of being both time consuming and expensive. It is indisputable that the Committee and the Administrative Claimants would propound discovery and retain experts to estimate the pre-petition and post-petition values of PNC's collateral in order to establish the amount of diminution PNC's collateral incurred.

30. Approval of the Settlement, therefore, is in the best interests of the Debtors, the general unsecured creditors, the Administrative Claimants and PNC as it resolves the litigation as to the amount of PNC's allowed super-priority administrative expense claim as well as the issue of distribution of the Avoidance Action Payments between the general unsecured creditors and the Administrative Claimants in the most cost effective manner available. The Settlement avoids the expense, time and distraction of complex litigation and is well within the range of reasonableness given the circumstances of these cases and the Parties' disputes.

31. Considering the foregoing, the Parties believe, in the exercise of their sound business judgment, that the proposed Settlement is in the best interests of the Debtors' estates and their creditors. Accordingly, the Parties, respectfully request that this Court approve the Settlement and grant the Settlement Motions in its entirety.

WHEREFORE, the Debtors, the Committee, PNC, and the Administrative Claimants respectfully request that this Court enter an order: (i) approving the Settlement Motion and (ii) granting such further and other relief as the Court deems just and proper.
