## Death Announcement – Rich Giangjordano, retired PPG Aerospace executive

GLENDALE, Calif., June 7, 2007 – It is with great sadness that PPG Aerospace announces the death of Rich Giangjordano, retired global general manager, insulating glass sealants. Giangjordano passed away May 24, 2007.

Giangjordano retired in May 2005 after 39 years of service with PPG and PRC-DeSoto International. He joined PRC in March 1966 at the insulating glass sealants manufacturing plant and business headquarters in Gloucester City, N.J., and he progressed through various insulating glass sealants positions to become general manager in October 1983. Giangjordano joined PPG with the acquisition of the PRC-DeSoto aerospace business in August 1999.

“Rich’s knowledge and expertise were well recognized by the insulating glass industry, and he forged strong customer relationships built on mutual trust, respect and high standards of meeting customer needs,” said David Morris, PPG vice president, aerospace. “Throughout his career, Rich introduced innovative products, including the *PRC* Series 500 Sealant System, which revolutionized the industry.”

Giangjordano was active in professional and industry trade organizations, serving as chairman of both the IGCC Guidelines and Equivalency Committee and the Sealed Insulating Glass Manufacturers Associations’ Technical Committee.

Memorial services were held May 28 in Westlake Village, Calif., and June 1 in Tabernacle, N.J.
